



Fig.2 Typical Output Characteristics

Fig.3 DC Current Gain vs. Collector Current (I)





Fig.4 DC Current Gain vs. Collector Current (II)

Fig.5 Collector-Emitter Saturation Voltage vs. Collector Current (I)





Fig.6 Collector-Emitter Saturation

Fig.7 Base-Emitter Saturation Voltage vs. Collector Current





Fig.8 Gain Bandwidth Product vs.





Fig.10 Safe Operating Area




COLLECTOR OUTPUT CAPACITANCE :  $C_{ob}$  [pF]




COLLECTOR-BASE VOLTAGE: V<sub>CB</sub> [V]

COLLECTOR TO EMITTER VOLTAGE: V<sub>CE</sub> [V]


